The mission of the Division of Sponsored Programs is to provide support for faculty and staff in the pursuit of external funding while assuring compliance with applicable regulations.

Sponsored Programs provides technical and compliance assistance in the following areas: identifying potential funding sources; developing proposals and budgets; facilitating compliance with federal, state, sponsoring agency, and University regulations; completing electronic applications; submitting proposals to sponsoring agencies; negotiating contracts and other award agreements; accepting award documents; administering post-award non-accounting issues, including subawards, award modifications, no-cost extensions, and budget revisions; administering the Institutional Review Board for the protection of human research subjects; administering the Institutional Animal Care and Use Committee; and administering internally-funded grant programs.

# Introduction

The 2021 fiscal year was a challenging year of necessary precautions related to the COVID-19 pandemic. For much of the year, in-person interactions were limited, and sponsored projects required creative approaches to continuing activities. We are proud of how well project directors adapted to necessary changes while continuing important work, and we appreciate the commitment and patience of all involved.

During FY 2021, EKU faculty and staff secured 82 sponsored project awards totaling \$86,082,419 in new external funding. This funding amount represents a record high for the University. However, more than \$54 million was awarded for institutional and student support through special funding allocations related to the COVID-19 pandemic. Without these funds, sponsored project funding would have been at a 20-year low. Some of this decrease has resulted from the elimination of agreements funding the provision of administrative services on behalf of the state. In recent years, the University has intentionally reduced the extent to which services are provided through contracts that do not fully cover associated indirect costs and that represent risk to the University.


In addition, there has been a notable decrease in faculty interest for pursuing sponsored project awards. Beginning with a survey we conducted in 2019, we have identified some areas of concern that function as barriers in managing awards. Our goal is to continue collaborating with administrative offices throughout the University to pursue solutions to these challenges. We encourage continued feedback from faculty and staff in this regard.

After a pause in the distribution of recovered Facilities and Administrative (F&A) costs in recent years, we were pleased to have been able to arrange for the distribution of a percentage of recovered F&A funds to project directors in FY 2021. The President's Cabinet approved a new distribution process with guidelines that require the submission of spending plan for distributed funds. Funds are set aside in accounts designed for use by the project director with a defined expiration date. For the foreseeable future, recovered F&A funds are expected to be distributed only for use by project directors. Certain units and programs are excluded from the distribution based on the nature of the awards.

As you read through this report, please join us as we celebrate the successes of faculty and staff who have secured external funding awards in support of the University's mission. External funding enriches the Eastern Experience through opportunities that are otherwise limited by financial resources, and we appreciate all those who have invested effort in securing funding and managing awards.

As we look ahead to FY 2022, we hope to see a renewed attention to the pursuit of external funding. If you are interested in exploring funding opportunities, we encourage you to <u>visit our website</u> to get started.



# **Historical Comparison of Funding and Awards**

Sponsored project funding on new awards totaled \$86,082,419<sup>1</sup> for the 2021 fiscal year. The chart below illustrates the funding trend over the last ten years.




**Total Funding by Year** 

While this historical data shows that FY 2021 was the highest funding year during the most recent 10-year period, this increase is attributable to the infusion of more than \$54 million in one-time funding authorized through Federal Acts in response to the COVID-19 pandemic. The number of awards in FY 2021 was lower than at any point in this same ten-year period as illustrated in the following graph.

Compared to a ten-year average of 104 new awards per fiscal year, 82 new awards began in FY 2021. In part, decreases in the last two fiscal years resulted from the University's intentional discontinuation of several programs.

# **Project Directors on New Awards**

Forty-eight (48) faculty and 24 staff served as project directors on 82 separate new awards that began during the 2021 fiscal year. Thirteen (13) faculty and four (4) staff served as first-time project directors. The chart below illustrates the number of faculty and staff project directors on new awards by college.<sup>2</sup>





The University received 82 awards that began in FY 2021. The number of awards for each college is reflected in the graph below with the five-year trend illustrated in the chart that follows.




#### Awards by College: Five-Year Trend






Number of Awards by Department




### Funding by College: Five-Year Trend










# **Funding and Awards by Purpose**


#### **Funding by Purpose**

# **Funding by Source of Funds**


Federal funds awarded totaled \$72,370,392, which represents 84.07% of the total amount awarded to EKU during the 2021 fiscal year. The federal funding total includes funding awarded directly to the University from Federal agencies as well as Federal funding passed through the State of Kentucky, awarded through subawards from collaborating universities, and granted through other pass-through entities. State-funded awards represent 15.82% of the total funding for fiscal year 2021 at \$13,617,194. The remaining \$94,833 (0.11%) was awarded by local and private sponsoring agencies. # **Proposal Submissions**

During the 2021 fiscal year, a total of 103 separate proposals were submitted by EKU faculty and staff. The following graph shows the number of proposals submitted by college. 

# **Faculty and Staff Submitting Proposals**

A total of 86 individuals (63 faculty and 23 staff) submitted proposals in FY 2021, compared to 90 in the previous fiscal year.<sup>3</sup> Of these, 16 (10 faculty and 6 staff) were first-time proposal submitters. 



#### **Faculty and Staff Submitting Proposals**

# **Subawards**




# **University-Funded Scholarship Grants**

During the 2021 fiscal year, Sponsored Programs processed 17 applications for University-Funded Scholarship (UFS) grants. For the fall and spring competitions, there were 13 mini-grant applications and 4 major project award applications submitted. Following the competitive peer review process, funding was awarded for two (2) major project awards totaling \$15,123 and 15 mini-grants totaling \$36,295. A total of \$51,418 was awarded to support faculty scholarship in FY 2021. The graphs below reflect the number of grants and amount of funding awarded by project type.




#### Number of UFS Awards by Type

# **Human Subjects Research Compliance**

The Institutional Review Board (IRB) for the protection of human research subjects is responsible for reviewing all research activities involving human subjects conducted by EKU faculty, staff, or students and is administered through Sponsored Programs. During the 2021 fiscal year, 174 research protocols were reviewed and approved by the IRB. Of these protocols, 115 were classified as exempt from further review under the federal Office of Human Research Protections (OHRP) regulations. Fifty-one (51) protocols were processed through the expedited review process, and three (3) protocols were approved after a full convened meeting of the IRB. Five (5) studies were approved through authorization agreements with other university or hospital IRBs. The graph below illustrates the number of IRB-approved studies by review type.



# **Animal Care and Use Compliance**

The mission of the Institutional Animal Care and Use Committee (IACUC) is to promote and safeguard activities within the EKU academic community that involve vertebrate animals. The IACUC review and compliance processes are administered through Sponsored Programs. Five (5) protocols were processed and approved by the IACUC during the 2021 fiscal year. These projects represent research and instruction activities involving vertebrate animal subjects.
