MISSION

The mission of the Division of Sponsored Programs is to provide support for faculty and staff in the pursuit of external funding while assuring compliance with applicable regulations.

Sponsored Programs provides technical and compliance assistance in the following areas: identifying potential funding sources; developing proposals and budgets; facilitating compliance with federal, state, sponsoring agency, and University regulations; completing electronic applications; submitting proposals to sponsoring agencies; negotiating contracts and other award agreements; accepting award documents; administering post-award non-accounting issues, including subawards, award modifications, no-cost extensions, and budget revisions; administering the Institutional Review Board for the protection of human research subjects; administering the Institutional Animal Care and Use Committee; and administering internally-funded grant programs.

Historical Comparison of Funding and Awards

Sponsored project funding on new awards totaled \$26,698,383¹ for the 2023 fiscal year. There were 149 active sponsored project awards during the fiscal year and 69 new awards. The chart below illustrates the funding trend over the last ten years.





Project Directors on New Awards

Fifty-one (51) faculty and 22 staff served as project directors or co-project directors on 69 separate new awards that began during the 2023 fiscal year. Sixteen (16) faculty and 11 staff served as first-time project directors or co-project directors. 
Awards by College


Awards by College: Five-Year Trend

Awards by Department



The chart below reflects the total amount of funding by college for the past five fiscal years.




Funding by College: Five-Year Trend


Funding and Awards by Purpose

A total of \$950,732 was secured through 19 awards for organized research. The remaining 50 awards provided \$25,747,651 in funding for other sponsored activities, including student services, training, instruction, and public service. Funding by Source of Funds


Federal funds awarded totaled \$15,981,295, which represents 60% of the total amount awarded to EKU during the 2023 fiscal year. The Federal funding total includes funding awarded directly to the University from Federal agencies as well as Federal funding passed through the State of Kentucky, awarded through subawards from collaborating universities, and granted through other pass-through entities. State-funded awards represent 38% of the total funding for fiscal year 2023 at \$10,243,750. The remaining \$473,338 (2%) was awarded by local and private sponsoring agencies. Proposal Submissions


During the 2023 fiscal year, a total of 97 separate proposals were submitted by EKU faculty and staff. The following graph shows the number of proposals submitted by college. For projects that include a project director and co-project director(s) from different colleges, proposals are reported for the project director's college.



Faculty and Staff Submitting Proposals

A total of 93 individuals (75 faculty and 18 staff) submitted proposals in FY 2023.² Of these, 35 (26 faculty and 9 staff) were first-time proposal submitters. The chart below illustrates the number of individuals submitting proposals during FY 2023 by college.


Faculty and Staff Submitting Proposals

University-Funded Scholarship Grants


During the 2023 fiscal year, Sponsored Programs processed 18 applications for University-Funded Scholarship (UFS) grants. For the fall and spring competitions, there were 10 mini grant applications and eight (8) major project grant applications submitted. Following the competitive peer review process, funding was awarded for six (6) major project grants totaling \$39,942 and three (3) mini grants totaling \$5,651. A total of \$45,593 was awarded to support faculty scholarship in FY 2023. The graphs below reflect the number of grants and amount of funding awarded by project type.

Human Subjects Research Compliance

The Institutional Review Board (IRB) for the protection of human research subjects is responsible for reviewing all research activities involving human subjects conducted by EKU faculty, staff, or students and is administered through Sponsored Programs. During the 2023 fiscal year, 186 research protocols were reviewed and approved by the IRB. Of these protocols, 107 were classified as exempt from further review under the federal Office of Human Research Protections (OHRP) regulations. Sixty-eight (68) protocols were processed through the expedited review process, and one protocol was approved after a full convened meeting of the IRB. Ten (10) studies were approved through authorization agreements with other university or hospital IRBs. The graph below illustrates the number of IRB-approved studies by review type.

Animal Care and Use Compliance

The mission of the Institutional Animal Care and Use Committee (IACUC) is to promote and safeguard activities within the EKU academic community that involve the use vertebrate animals for research or instructional purposes. The IACUC review and compliance processes are administered through Sponsored Programs. Four protocols were processed and approved by the IACUC during the 2023 fiscal year.
